Introduction

The administrative year 2021 saw the Association embarking on a number of initiatives geared towards accomplishing its stated objectives.

Report from Sections

Academic Libraries

INTRODUCTION

In keeping with the Academic Sections' objectives of distributing timely and relevant information that will keep Academic Librarians informed of happenings within the field, we note that several institutions welcomed new Library Administrators and supporting staff, while some had staffing being redeployed to other areas within their respective institution.

This report covers activities for the period February 01, 2021, to January 25, 2022.

1. PROPOSED ACTITIVITIES

- a) Conducting Training Needs Analysis/Interest Assessment before embarking on initiatives'
- b) Liaise with Membership and Conditions of Service, and other Sections/WPs in the hosting of webinars.
- c) Library Week collaboration with Membership & Conditions of Service W.P.
- d) Periodically sharing with our personal and institutional members' current library trends, and issues and available training opportunities via email, social media, website etc.
- e) Liaise with IT and PR working parties to promote information and activities.

2. MATTERS COMPLETED

- A) Identification and formation of working committee, and the formulation of the Academic Section's Strategic Plan was done and submitted to the Executive.
- B) The creation of a dedicated email address for the Section: liajaacademic@gmail.com

C) WEBINARS/CONFERENCES/SEMINARS

Our membership participated in various webinars, conferences, and seminars throughout the reporting period, as outlined below:

April 13, 2021 - This webinar explored how the principles of trauma-informed care and Mental Health First Aid could equip Library staff with the knowledge and confidence to communicate with compassion.

April 15, 2021 - This webinar addressed COVID-19 vaccines and how they impact the reopening and ongoing operations plans for libraries, archives, and museums.

April 18, 2021 - This webinar focused on self-care strategies for library staff, to respond to the physical, behavioural, and emotional impacts of workplace stressors.

May 20, 2021 - *Is your library prepared for a cyber-attack?* Summary: Cyber-attacks on institutions of higher education are becoming more common, but many academic libraries have yet to prepare for a cyber-attack, the impact it has on operations, and the lasting repercussions on people and services.

MBCC RESEARCH WRITING WEBINARS AND RESEARCH WEEK (TARGETING ACADEMIC LIBRARIANS)

Webinars were implemented on June 1st, 10th and 22nd and the presenters were Dr. Sasekea Harris, Dr Sonja Robinson-Madden and Dr. Ruth Baker-Gardener respectively. I am happy to report that Academic Section was well represented at these sessions thirteen (13) on the 1st, ten (10) on the 10th and fourteen (14) on the 22nd).

The inaugural Research Week was observed between November 1st and 5th under the theme: "ALIGNING RESEARCH TO INDUSTRY NEEDS FOR GROWTH AND SUSTAINABILITY" The Academic support was overwhelming.

October 6, 2021, saw several Academic Librarians participating in EBSCO's "Open Research" webinar with Mike MacKinnon and Tamir Borensztajin.

D) ADVOCACY TRAINING

The Academic Section was represented at the Train-the-Trainer advocacy training sessions held on June 15th and 16th and hosted by the American Library Association.

1. Shortwood Teachers' College:

 A new circulation system will be "rolling out" this semester. We will be seeking assistance in training from National Library of Jamaica.

2. Sam Sharpe Teachers' College:

- The period from June 16 to September 21, 2021, was very low keyed mostly due the COVID-19 pandemic. Final Semester Examinations were held from the period July 1-14, 2021.
- A presentation on "Online Resources" was done virtually for Postgraduate-Diploma students by Librarian Mr. Kevin Samuda on July 5, and for Year 1 & 2 Evening College students on July 12, 2021.

3. St. Joseph's Teachers' College:

• The College conducted a 1-week orientation for year 4 practicum students from September 6th to 10th. The Librarian, Ms. Tamara McCrea did a session on the library resources.

4. Moneaque Community College:

The library continues to be in operation despite the pandemic being faced.
 We have a full complement of staff members reporting for work daily. Since the start of the academic year, 2021-2022, some staff members have been asked to sit in and assist other departments.

5. Bethlehem Moravian College:

- C.C.C.J. students' classes commenced Monday, September 20, 2021, online.
- Colloquium 2021 took place on Thursday, September 9, 2021, for all categories of staff.

6. Knox Community College:

• The Library staff successfully added all book titles to the ISIMS platform.

7. Brown's Town Community College:

• The College Library continues to follow the COVID-19 prevention and control protocols.

8. Montego Bay Community College

- Library week took place October 25 29, 2021. Various training sessions were scheduled during the week to accommodate both students and staff. Participants were asked to complete an evaluation form, it consisted of forty-three (43) respondents. 73.8% thought the session were relevant to completion of assignments etc., while 26.2% thought they were highly relevant. Of the 43 respondents 32. 6% preferred a time of 6:00 -7:00 p.m. for future training sessions such as these.
- Library and Information Professionals' Day was celebrated on Thursday, November 4, 2021, the library staff were feted with cake and wine.

9. Catholic College of Mandeville -

10. KNOCKALVA POLYTECHNIC COLLEGE

• The College Librarian volunteered with the Great Shape Super Kids Inc.

Literacy Project in Negril in September for 5 days. This initiate was endorsed by the Ministry of Education and Sandals Foundation. The children were taught Language Art using various teaching methods to help increase their vocabulary and reinforce letter sounds. The volunteers from North America, Canada and Jamaica were able to teach Computer Science, Physical Education, Language Arts, Art using songs and games to enrich their literacy skills.

 The College Librarian was selected as the 2021 – 2022 League Excellence Award Recipient. The League for Innovation in the Community College (League) is an international nonprofit organization with a mission to cultivate innovation in the community college environment.

11. Mico University College:

- The University recently launched its digital library, and they are now in the process of marketing it.
- The Mico University College will be celebrating 185 years this year and as a
 result the library is responsible for creating a digital exhibition which would
 include a lot of information on the University College. This include covering
 the school's history, past achievement and what we intend on achieving in
 the future.

12. Caribbean Maritime University:

- The Library staff attended several webinars both locally and internationally.
- Library staff is conducting research on a reference chat services that can be used to assist users, especially since the University is operating in a virtual space. We will be asking the IT Department to develop a chat service for us on one of the teaching platforms.

13. Northern Caribbean University:

- During the month of August liaison librarians delivered information literacy sessions and library orientation to faculty and staff as the University prepared to welcome new students and staff. The library participated in the 2nd virtual New Workers Welcome and Orientation and the New Students Orientation on August 17 and August 25 respectively.
- Miss Denise Hunter, Cataloguing Librarian has published an article in the Journal of Adventist Libraries and Archives titled "School Libraries should be equipped to Operate in the Virtual Space". The article highlighted the situation with school libraries in the Caribbean not being equipped to operate in the online environment in this COVID-19 period when online teaching and learning is predominant. She implored schools to get their libraries online, instead of simply reassigning the Librarians to other

duties or using the library space for other activities, since online services are likely to continue after the pandemic has ended.

14. University of Technology, Jamaica

- Two (2) Librarians attended the Caribbean Association of Librarians conference.
- The library continued to be in involved in Information Literacy sessions which is a part of our academic writing modules. All librarians are scheduled to conduct these sessions. For the third-year students, the librarians conduct Research Method session to help with accessing online sources and using APA effectively.

ACADEMIC LIBRARY STANDARDS

We await the final version of the revised "**Standards for Academic Library**" currently being worked on by COLINET. Indications are that both digital and printed formats will be available.

STAFFING AND GENERAL OPERATIONAL ISSUES

Institutions reporting that Para-Professional (Library Assistants) are now back in their substantive positions, having previously assigned to non-library duties. Most Academic Librarians reported that they are currently operating from office after a period of working from home. We note that only a few Academic Librarians reported receiving devices from their institutions to facilitate working from home. Many have had to be used their personal devices and some had to be sharing with family members which would have affected work schedule. Most Libraries are now offering blended services

INFORMATION LITERACY

The Section received several inquiries from Academic Librarians requesting assisting in the formulation and delivery of Information Literacy to first year students.

Workshops in partnership with Jamaica Library Service

The highlight of the year was a series of workshops dubbed "School Libraries on the Information Highway" which was done in partnership with the Jamaica Library Service. This series ran from Wednesday, February 24, 2021 to Thursday, March 25, 2021, *via Zoom*. Of the twelve sessions which were planned, 10 were done. The two sessions which did not materialise were "Cataloguing with RDA" and "Proposal Writing". The sessions were attended by a total of 318 persons including those from school, public and academic libraries.

This series was offered free of cost and was designed to help school libraries to tailor their services to the online environment so that they can offer at least minimal service. The workshops topics and dates are displayed on the table below.

The Education and Training Working Party was able to achieve the following during its 2021 tenure:





Research and Publications

The Working Party continues to aim for its goal of promoting research and information sharing initiatives through:

- Capturing and sharing ideas and experiences regarding research relevant to the field of Library and Information Management; and
- Encouraging and supporting further research and innovations in the field Library and Information Management.

Although the objective of publishing the LIAJA Journal for the year 2021 was not realized, Dr. Sasekea Harris continues to spearhead work being done on the LIAJA Journal, with the hope of publishing in the year 2022.

Reports of Sub-Committees

Advocacy

The focus of the year's activity was on building a foundation for a sustainable advocacy platform for LIAJA. To this end, two half-day Advocacy Academy training sessions were arranged and conducted free of charge by Megan Cusick, Assistant Director, State Advocacy, Public Policy & Advocacy of the American Library Association on June 15th and 16th, 2021. Ten (10) members of the Executive attended the training, which explored the five key steps in library advocacy planning and included a manual to be used for future train-the-trainer exercises on advocacy. The knowledge and insight gained from the sessions will be an important element in developing a long-term advocacy campaign for LIAJA, including the active participation of all members as library advocacy champions.

The Advocacy Sub-Committee also continued its relationship with the International Federation of Library Associations (IFLA) in coordination with Mr. Stephen Wyber, Manager, Policy and Advocacy, IFLA. We were kept abreast of a consideration to reform Jamaica's copyright law to facilitate access to accessible-format works for people with print disabilities (in line with the Marrakesh Treaty); Jamaica's plan to undertake a Voluntary National Review of its implementation of the United Nations Sustainable Development Goals (SDGs) in 2022; and to support IFLA's work in strengthening capacity to speak up for libraries everywhere by participating in the IFLA Survey on Regional Advocacy Priorities. Work continues to facilitate updating the information related to libraries in Jamaica, on IFLA's Libraries of the World Campaign. We also collaborated with IFLA through their Guide to Library Engagement in Voluntary National Reviews to ensure that the role of libraries in driving development is recognised and supported in GOJ's 2022 Voluntary National Review of its implementation of the United Nations Sustainable Development Goals (SDGs).

The Advocacy Sub-Committee continues work to identify and develop strategic partnerships with local organizations and is working to identify and develop proposals for ways in which LIAJA could add value to the work of potential strategic partners and/or create new joint initiatives.

Work also continued on the "Librarian Series" under the direction of the National Library of Jamaica.

Unfortunately, because the Sub-Committee essentially operated as a party of one, for the duration of the year, it was difficult to adequately address all areas of the Group's mandate as desired. For example, the response to the Editor, Jamaica Observer highlighting the role/work of Librarians after the cartoon (shown below) which appeared in the newspaper on November 5th.



I nevertheless thank, Mrs. Vergie-Lee Lawson and Ms. Audrey Saddler, both of the Main Library, The University of the West Indies, Mona Campus, who did indicate an interest in serving on this Sub-Committee but were unable to do so because of the demands of work and health concerns. I encourage us all to become more involved in the affairs of our Association for as Helen Keller stated "Alone we can do so little; together we can do so much!"






The Department of Library and Information Studies (DLIS), Graduate Research Seminars



Jamaica Library Service

The Jamaica Library Service (JLS) remained steadfast in its support of the Ministry of Education, Youth and Information throughout the year 2021. Though several challenges were brought on by the COVID-19 pandemic, opportunities were also presented for the organization to be adaptable in meeting the information needs of its users. This included the steady strengthening of the JLS capacity to provide library users with remote access to virtual services. The hosting of library events and programmes islandwide were also modified to facilitate both face-to-face and virtual modalities to engage users in their unique spaces.

The JLS continued to garner significant support through networking with its stakeholders and the establishment of meaningful partnerships among other achievements.

PARTNERSHIPS

Malvern Branch Library Renewable Energy Initiative with BMR Energy

The Malvern Branch Library, St. Elizabeth is the beneficiary of a renewable energy system donated by BMR Energy. The system was commissioned at a virtual ceremony held at the Branch Library on November 3, 2021, endorsed by the Minister of Education and Youth and the Minister of Energy, Science and Technology. The system comprises a 4-kw solar electricity generating panels providing 13.5 Kw of renewable energy. The project is intended to increase individual and community awareness of the value of renewable energy and reduce the cost of electricity at the Malvern Branch Library. The library is a great location for field trips for students of educational institutions to visit and participate in information sessions on green energy/solar technology and to view the renewable energy corner, complete with storyboard and a phone charging station.

The ceremony was one of the events on the week of activities in observance of **Library and Information Week**. The ceremony was hosted by RJR 94 FM outside broadcast of the Hotline programme with presenter Clive Mullings. Several interviews were facilitated with participants of the ceremony, as well as other stakeholders, namely: A radio outside broadcast was also a feature of the ceremony, promoting the work of public libraries across Jamaica.

Memorandum of Understanding with the Accountant General's Department

The JLS signed a Memorandum of Understanding on Thursday, November 18, 2021 with The Accountant General's Department for the installation of Electronic Dropboxes at select parish and branch library locations. This partnership will serve to improve service delivery in the public sector, specifically to broaden the options for the collection of Life Certificates for greater efficiency in making payment to government pensioners. The partnership commenced with a pilot at the St. James Parish Library Network and included the installation and commissioning of the Dropbox and training of 12 staff at the parish library. Pensioners will also have the opportunity to become members of the library and access programmes and services offered.

JLS/CHASE Fund Partnership to support Virtual Learning

The JLS continued to support the Ministry of Education's mandate approaches to ensure that teaching and learning continued despite the COVID-19 pandemic for the 2021 academic year. Students, parents and teachers were provided with access to ICT resources, reading and research material and on-the-spot-training to utilize various learning platforms at JLS locations across the island.

As part of the efforts to increase access and contribute to reducing the digital divide, the JLS approached CHASE Fund with a proposal for acquiring laptops, tablets and multifunctional printers for 25 remotely located branch libraries islandwide. CHASE funded the initiate which bolstered the availability of digital devices to support access to the MOEYI student/teacher online engagement of teaching/learning in these communities.

PROGRAMMES & SERVICES



The 2021 season of the National Reading Competition (NRC) themed "Stay Connected and Read" was launched on April 8, 2021. The event was streamed live on the JLS' Social Media



pages with a total of four hundred and forty-nine (449) viewers in attendance via Zoom, Instagram and YouTube. The National and Parish Champions for 2020 were announced at the event. LIAJA was also featured as one of the sponsors of the event and acknowledged for the continued support through contribution of trophy and cash award for the Best Letter in the 6-8 age category.

The 2021 Competition concluded with over 1,000 competitors registering online for participation. This represents a 40% increase in participation when compared to 2020 when the competition was first impacted by the Covid -19 pandemic. The national champions and runners up will be announced in 2022.



Annual Summer Programme

The 2021 Annual Summer Programme was coordinated at select public libraries islandwide using a blended approach of face to face and online delivery methods under the theme 'Stay Connected and Read'.

The Manchester and Kingston & St. Andrew Parish Library Networks also partnered with the National Environment and Planning Agency (NEPA) to sensitize participants of the importance of protecting the environment.

Observances

National Career Week 2021

The Jamaica Library Service partnered with the Ministry of Education and Youth, Heart NSTA Trust and Junior Achievement Jamaica in observance of National Career Week from February 6 to 12, 2021 guided by the theme "Executing the Vision through Career Development: I Think it, I can be." As part of the partnership the JLS coordinated activities which included the launch of a virtual exhibition and the mounting of physical exhibitions highlighting careers in Librarianship. The events featured over 600 participants online.

Salt Awareness Week 2021



In observance of Salt Awareness Week the JLS partnered with the Heart Foundation of Jamaica (HFJ) to execute a week of activities from March 8-12, 2021 under the theme 'More Flavour, Less Salt'. The activities were aimed at highlighting the implications of excessive salt consumption and to educate the population about hypertension and hidden salts in processed foods. The activities were streamed live and made accessible via the JLS YouTube channel. Collectively the events generated two hundred and seventy (270) views.

Read Across Jamaica Day

The JLS observed Read Across Jamaica Day on May 4, 2021. Over 16 reading sessions to heighten awareness of the importance of reading were facilitated islandwide through online platforms such as Google classroom, Zoom,

YouTube and WhatsApp, impacting over four hundred & forty-seven (447) students.

The Portland Parish Library Network hosted an event themed, 'Nuturing A Passion for Reading' which was streamed live via the JLS Facebook and YouTube platforms. A highlight of the event was the participation and engagement of persons with disabilities including the hearing impaired. The entire event was translated by



a Sign Language Translator. Four hundred and eighty-one (481) persons participated online.

10th Annual Marcus Mosiah Garvey Lecture

The St. Ann Parish Library collaborated with the St. Ann Homecoming & Heritage Foundation and UWI TV for the virtual staging of the 10th Annual Marcus Mosiah Garvey Lecture on June 11, 2021. The event was held to commemorate the 81st anniversary of the National Hero's death. The lecture titled "Marcus Garvey and the Black Lives Matter Movement in the 21st Century" was delivered by guest lecturer the Most Hon. P.J. Patterson, ON, OCC, PC, QC.

Library and Information Week 2021

The Art of Storytelling Workshop


The JLS in partnership with Ntukuma hosted, two virtual workshops titled the Art of Storytelling on Friday, January 14, 2022 and Thursday, January 27, 2022 for paraprofessional staff. The objective of the workshop was to enable the staff to develop a greater level of appreciation for the art of storytelling and its importance to authentic and transformational culture. The sessions would also enable staff to better utilize the art form to support the delivery of other library programmes, events and activities including establishing storytelling clubs in schools and public libraries islandwide. A total of seventy-three (73) staff participated.

SCHOOL LIBRARY NETWORK

Teacher/Librarians' Seminars

The School Library Network hosted a series of virtual Teacher/Librarians' seminars under the theme *School Libraries in a Technologically Changing Environment*. The first seminar in the series was held on Wednesday July 7, 2021 with a main presentation titled 'Developing a Plan for ICT Implementation' delivered by Mr. Adrian Gilman, Acting Deputy Director, Database and Network. Nineteen (19) members of staff and thirty-seven (37) Teacher/Librarians from thirty-five (35) schools participated in the seminar.

As part of the JLS week of activities for **Library and Information Week**, the second seminar was held on Wednesday, November 3, 2021 with the main presentation titled 'Introducing Books to Children.' The topic was selected in recognition of reading being foundational to learning and to support teacher-librarians' in the education recovery efforts to combat the learning loss experienced by Jamaican students since the pandemic. The workshop included a panel discussion with four Children's Authors and a presentation titled "Benefits"



and Methods of Introducing Books to Children as well as some available Online Resources". The four children's authors, namely Tanya Batson-Savage, Jean Hawthorne DaCosta, Diane Browne and Dr. Cherrell Shelley-Robinson, engaged the participants on the importance of reading and motivating children to read; shared samples of their work in exposing children to books in a fun way and shared insights on what inspired them to write for children. Twelve (12) members of staff and forty-five (45) teacher-librarians participated.

INTERNATIONAL ASSOCIATION OF SCHOOL LIBRARIANSHIP Annual Conference

The 49th Annual Conference of the International Association of School Librarianship (IASL) in Denton, Texas, United States of America was hosted virtually from July 12 – 16, 2021. This staging also marked the 24th International Forum of Research on School Librarianship. Eight (8) representatives from the JLS, comprising the Director General, Senior Director, Director, School Library Network, five Regional Directors and a Senior Librarian attended the conference.

The 2021 theme "A Rich Tapestry of Practice and Research around the World" permeated the presentations which provided several insights that continue to resonate with the JLS attendees. The author keynote presentations were also a highlight and provided a vivid reminder (supplemented by several references to current research) of the power of reading to engage and support individuals and communities. The conference focused on international trends and innovations in school librarianship as well as first-hand research on multiple literacies, learning challenges, bibliotherapy and open schooling.

The presenters from countries in North America, Europe, Africa, Australia and Asia demonstrated how school libraries across the world have assisted with bridging the gap resulting from the COVID-19 pandemic by focusing on engaging students creatively through the use of books, digital tools, collaboration and fostering a sense of community.

IASL Newsletter

The Jamaica Library Service was featured in the **January 2022 International Association of School Librarianship Newsletter** in an article titled 'Jamaica Library Service – Weaving Threads of Insight from the 2021 IASL Annual Conference' which highlighted the Teacher Librarian's Seminar held in November 2021 on Introducing Books to Children.
